

TOGETHER, LET'S STAY MOBILISED!

In September 2021, let's safely meet at the IUCN World Conservation Congress by implementing and complying with the following health measures*:

MAIN HEALTH MEASURES

ACCESS / PREVENTION



- The health pass (electronic or paper) will be required for all participants and general public visitors (individuals and groups) each time they enter Parc Chanot (adults only). The health pass will be required from 1 to 11 September at the entrance to Parc Chanot for all without exception (except underage children)
- Setup of a temporary antigenic/RT-PCR test centre for non-vaccinated or non-immunized delegates, exhibitors and staff. Online appointments [available here](#) as of 23 August.
- Counting of participants at the entrances of Parc Chanot and real-time monitoring of the event capacity gauge
- Activation of the TousAntiCovid app

INFORMATION / AWARENESS

- Communication of health measures in advance of the Congress
- Displays reminding participants of social distancing barriers
- Maximum capacity displays and social distancing markers in waiting areas and at room entrances
- Loudspeaker announcements reminding participants of health instructions



WEARING A MASK, PROTECTION, HAND SANITISER



- Wearing a mask is compulsory indoors and outdoors for everyone over the age of 11, and strongly recommended for those ages 6-11
- Installation of plexiglass screens on Congress reception/information desks
- Hand sanitiser distribution terminals available at the entrances to Parc Chanot, all buildings, and in the main aisles

TOGETHER, LET'S STAY MOBILISED!

In September 2021, let's safely meet at the IUCN World Conservation Congress by implementing and complying with the following health measures*:

DISTANCING



- Enforcement of distancing measures are applicable to standing persons (1 meter apart) as well as in conference rooms
- Physical indicators for queues and waiting spaces
- Separate spaces for entering and exiting rooms and buildings
- Directions to guide the internal movement of participants within the entire area, where possible

DISINFECTION, CLEANING, AIR FLOW

- Limitation of contact surfaces and objects, in particular with signage and other communication devices, and in catering areas
- Regular disinfection of remaining contact objects and surfaces
- Implementation of specific Covid-19 waste bins
- Thorough cleaning of spaces
- Continuous flow of fresh air through the premises using natural or mechanical ventilation (with 100% outdoor air)



CATERING

- Digital menus and individual dishes and portions served
- Maximum 6 people per table, 2m between the tables
- Disinfection of tables between each customer

MANAGEMENT OF SYMPTOMATIC CASES

- Rapid care procedure, in connection with first aid team
- Specific Covid-19 isolation room with outdoor access and ventilation

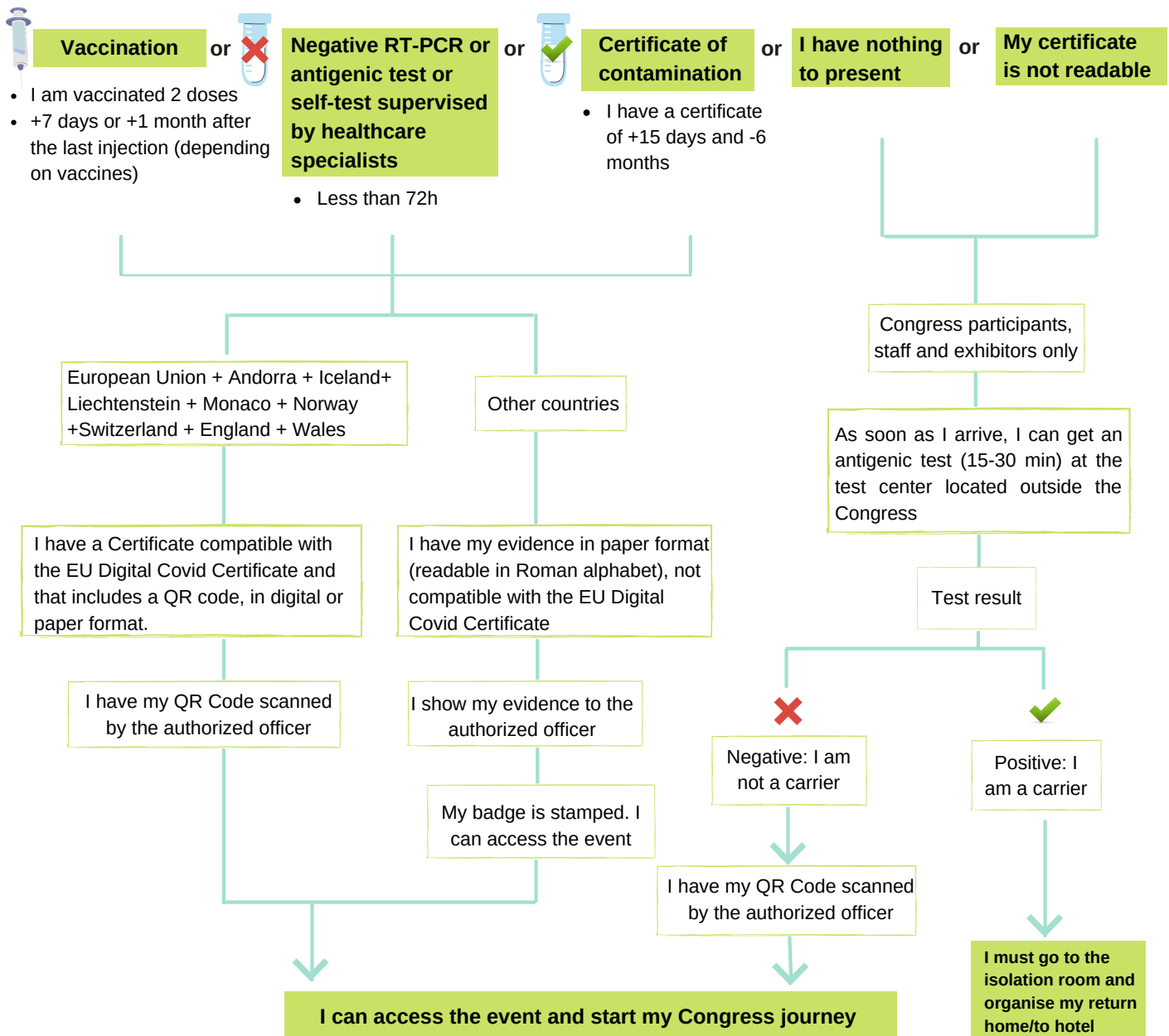

HEALTH PASS

For the safety and comfort of all, it is essential to protect ourselves and minimise the risk of Covid-19 transmission.

The health pass will be required for all participants and general public visitors (individuals and groups) each time they enter Parc Chanot (adults only). The health pass will be required from 1 to 11 September at the entrance to Parc Chanot for all without exception (except underage children)

The health pass also applies to the organisers, the various service providers and exhibitors / project leaders from 1 to 11 September



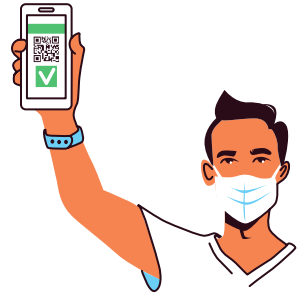

In September 2021, let's safely meet at the IUCN World Conservation Congress by implementing and complying with the following health measures*:

HEALTH PASS - OTHER PLACES

Outside the Congress, the health pass can only be controlled by presenting a QR code compatible with the EU Digital Covid Certificate.



Compatible QR codes on vaccination and RT-PCR test certificates can be uploaded to the TousAntiCovid App by scanning them. This App is available for French as for foreigners (via the [Playstore](#) or the [Appstore](#)). The language of the App can be switched to French or English (to be changed in the settings).



For people who have been vaccinated in one of the following countries, your vaccination country already provides an EU Digital COVID Certificate that includes a QR code accepted in France and that you can upload to the TousAntiCovid App:



- EU Member States
- Andorra, Iceland, Liechtenstein, Monaco, Norway, Switzerland



- For the **UK (England and Wales)**, your certificate will also be recognized, although it is not part of the EU Digital COVID Certificate.



To get a compatible QR code, several solutions exist:

- Do an RT-PCR test in France (every 72 hours). A QR code will be sent to you.
- For vaccinated people, with one of the vaccines approved in France, you can apply for a conversion of your vaccination certificate. A French QR code will be sent to you. Note: this service is recent, and given the high number of applications, it is not guaranteed that you will receive this QR code before and during your stay.
